

This is of course to help teachers to be able to create more meaningful learning designs. 

(Ida Wirnaningsih:2022) Imran Tutuli on the Gorontalo Supervisory website explained that there are six Pancasila student profiles as the goal of implementing the independent curriculum. These profiles include: 1. Have faith and fear in God Almighty and have noble morals: Indonesian students who believe, are devoted to God Almighty and have noble morals are those with character in relation to the Almighty. He understood the teachings and beliefs of the religion and applied them in his daily life. Faith, devotion to God and noble morals have five key elements: (a) religious morality; b) personal morality; c) morality for people; d) morality towards nature; and (e) the morality of the nation.

I The application of TPACK-based learning encourages teachers to be able to make meaningful lesson planning, in line with the implementation of the independent curriculum. Freedom to learn and freedom to teach. An educator must try to produce his students an individual who is brave, independent, astute in getting along, civilized, polite and competent. (Anita Dwi B :2021) As explained above, the character components that want to be built from the perspective of Pancasila student profiles include critical and independent thinking. Through learning with the TPACK approach, teachers encourage students to think critically, realized by their independence in solving problems in learning. All parts in TPACK are interrelated and have major implications for learning. (Titin Mairisiska :2014) Through the digital-based Learning Implementation Plan, students will be more interested and motivated. TPACK-based learning tools developed in the Learning Implementation Plan (RPP) and Student Activity Sheet (LKS) in the form of ebook page flig have optimized student learning activities in the material colligative nature of the solution and can improve students' critical thinking skills. (Titin Mairisiska1, Sutrisno, and Asrial2: 2014) Learning with the TPACK approach can be presented by various methods. The TPACK framework is developed through technology in the form of learning media for students, that is, online comics that can attract interest also facilitate students in the material learned and help in influencing students in critical thinking.
